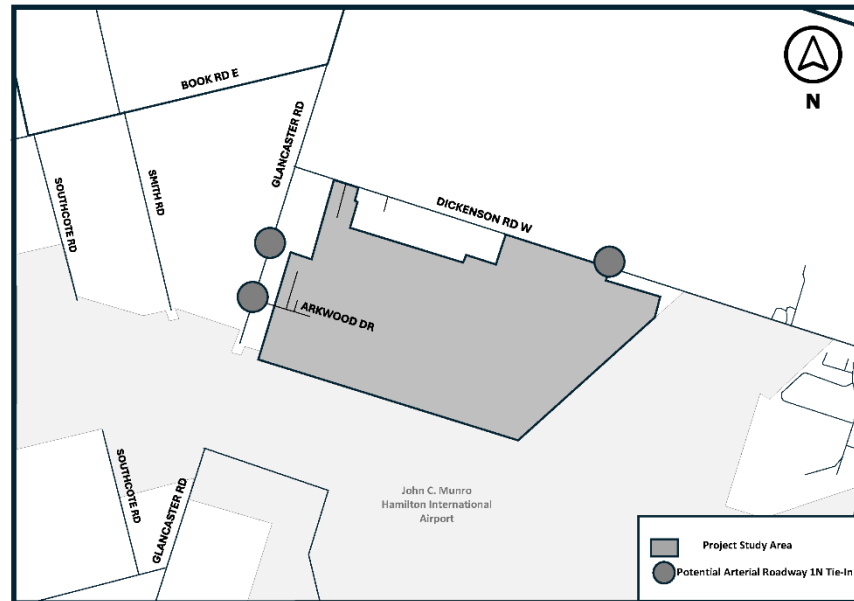


Arterial Roadway 1N – Dickenson Road West to Glancaster Road

Municipal Class Environmental Assessment – Phases 2-4 Notice of Study Commencement and Public Information Centre (PIC) #1

Background

Dickenson Limited Partnership has initiated a Draft Plan of Subdivision process for a new industrial development adjacent to the John C. Munro International Airport within the City of Hamilton's Airport Employment Growth District Secondary Plan lands. In parallel with the Draft Plan of Subdivision process, the applicant is conducting



the Schedule C Municipal Class Environmental Assessment (EA) process for Arterial Roadway 1N, from Dickenson Road West to Glancaster Road, within the private development lands.

Process

The project will fulfill the Schedule C project under the Municipal Engineers Association EA process as described in the Municipal Class Environmental Assessment guide document (October 2000, as amended in 2023). This PIC will fulfill the requirements of Phase 2 of the EA process.

Public consultation is a key component of this study. This PIC will present an opportunity to review the project, impact and mitigation measures and the preliminary preferred alignment.

In addition, there will be an opportunity to review the final Environmental Study Report (ESR) when it is complete.
